MBA/SMP/AMP CHARTERED BANKER PROGRAMME



KEY FEATURES OF THE PROGRAMMES

A dual qualification for the achievement of both the Master of Business Administration (MBA) and the professional designation of CHARTERED BANKER.

The Programme has two variants:

- **MBA Programme**
- **Executive MBA Programme:**
Regular Executive MBA (EMBA) and the Modular Executive MBA (MEMBA)

The Modular Executive MBA (MEMBA) is a mixture of both physical and online classes which allows more flexibility and is especially convenient for those outside Lagos as it only requires being on campus every two months, while most of the classes are taken online.

The regular Executive MBA (EMBA) requires class attendance on Fridays and Saturdays for two years.

The Full-time MBA (FTMBA) encompasses the physical class format and Modular MBA (MMBA) Programmes is for the online format.

CIBN Elective Track (For Existing MBA Holders): Participants who already have an MBA from recognised institutions can take only the CIBN route and those who pass would be awarded the Chartered Banker qualification.

The Elective track has six (6) subjects of the Banking Professional Examination Syllabus including the CIBN Core Courses.

The core courses are:

1. Finance in the Global Market
2. Bank Management and Strategy
3. Lending and Credit Management
4. Applied Banking

The Senior Management Programme and Advanced Management Programmes Chartered Banker categories.

A dual qualification for the achievement of Senior Management Programme, Advanced Management Programme and the professional designation.

CIBN Elective Track:

This is an option for participants who already have an SMP or AMP from Lagos Business School to take the CIBN module alone and those who pass would be awarded the Chartered Banker Qualification

The CIBN core courses are incorporated as additional module to the SMP and AMP.

The Programme allow for flexible Installmental payments.



ENTRY REQUIREMENT

MBA/CHARTERED BANKER Programme Category

MBA PROGRAMMES

- At least 5 Credit passes including English and Mathematics at O'Level
- Minimum of a second-class lower degree from an accredited University
- MBA/ACIB Programme Category
- A good GMAT, GRE or NMAT score
- At least three years post graduate work experience

EMBA and MEMBA Programmes

- Participants for admission into the Executive MBA Programme must satisfy the following requirements
- Credit passes in English and Mathematics at O'Level.
- At least a second class lower university degree from a recognized university; or Higher National Diploma together with a postgraduate diploma; or an acceptable professional qualification together with a postgraduate diploma.
- At least seven years of professional experience.
- A satisfactory performance at the university's admission test or the GMAT

- Satisfactory evaluation of the participant's intellectual capacity, professionalism, maturity, past professional experience and motivation for work, through an interview.
- As participants will have to combine the demands of the Programme with their work, explicit approval of the company allowing the participants to undertake these studies will also be required.

Senior Management Programme (SMP/Chartered Banker)

Participants for admission must be Senior Managers with 7 years senior management experience.

Advanced Management Programme (AMP/Chartered Banker)

The Advanced Management Programme is for Executive Directors and General Managers who are preparing to lead multifunctional organisations. It is a transformational experience that helps participants perfect their leadership capabilities such that they can advance their organisations, knowing which levers to pull to create an environment that delivers on set objectives.



WHO WOULD BENEFIT FROM THE PROGRAMME?

- The Senior Management Programme is for senior managers with at least seven years of senior management experience, such as Functional Senior Managers/Executives, Regional Managers, Unit Heads, General Managers, and Assistant General Managers.
- Aspiring professionals seeking to acquire a postgraduate certification

- The Advanced Management programme is for General Managers, Directors and second level CEOs, who are preparing for higher responsibilities.
